## Gray Perry Young Collegiate Piano Award Competition

In 1994 the Young Collegiate Piano Award was established by FSMTA in order to encourage college pianists in their first and second years of college study. In 1996 the event's name was changed to honor the memory of Florida teacher Gray Perry. The competition is held at the annual State competitive Events Day in the spring of each year. The first place winner receives a cash award from the Florida State Music Teachers Foundation and other contestants receive certificates.

### Rules applicable to all FSMTA student competitions:

**Teacher eligibility:** Current membership dues of MTNA/FSMTA must be paid on or before October 1<sup>st</sup> of the current fiscal year to be eligible to enter students.

It is the responsibility of the teacher to be able to provide proof that dues were paid on time. An exception to the October 1<sup>st</sup> deadline will be granted to teachers joining MTNA/FSMTA for the very first time. This one time exception will allow the teacher to pay national and state dues on or before the competition entry deadline.

**Competition Rules:** At least one copy of the repertoire, unmarked except for measure numbers, shall be presented to the judges. No photocopies will be accepted and, if presented, the student will automatically be disqualified. Should a contestant have a bona fide reason for using a photocopy, he must notify the competition chairman in writing in advance of the competition.

Taping of any kind is not permitted during the competition, nor is taking of photographs.

Three judges having no connection with any student entered will audition students on performance. All decisions of the judges are final and will not be subject to further review. Judges have the right to declare no winner. One entrant in a competition category does not automatically guarantee a winner.

Questions or problems arising from competitions should be handled by the teacher of the student through the appropriate competition chairman. Parents are not allowed to contact any chairman.

### Other rules for the Gray Perry Competition

**Eligibility:** Any student registered in Freshman or Sophomore piano study at a private or public university in the State of Florida. (**Note:** Because the competition usually takes place in May or June, the student must have been registered in the semester prior to the competition.)

**Repertoire Requirements:** Contestants must perform two or three memorized pieces or movements from contrasting style periods, with a total length of 15 to 20 minutes. Programs exceeding 20 minutes will be stopped. No concerto movements will be accepted.
